

A. Consider, discuss, and act upon authorizing a Memorandum of Understanding with the Northern Rhode Island Forest School subject to review by the Town Solicitor.

Environmental Scientist Diana Brennan and English teacher Lindsey Baillargeon are present to give the council members the background on their proposal to use a portion of Wolf Hill to establish and use as a nature classroom.

Ms. Baillargeon explains that they see an opportunity for children that are used to traditional learning to take them outside to the forest and to use literacy and scientific lessons to make learning experiential. Ms. Baillargeon further explains that this would bring "project base" and "inquiry based" learning into traditional education, which is the most effective for children to achieve mastery. Ms. Baillargeon also explains that this is helpful for many learners, including neurodivergent learners, who are sensory seekers and have physical needs.

Ms. Baillargeon states that vocabulary scientific terminology will be taught. Ms. Baillargeon further states that students typically struggle with nonfiction text, which impacts the understanding of fictional text, and studies show that if you focus more on nonfiction by making it experiential, student's comprehension improves.

Ms. Baillargeon further states that the pandemic caused learning loss and this would help in those areas of literacy that students typically struggle in, especially neurodivergent students.

President Lawton asks what the age group will be. Ms. Baillargeon states the age group is four (4) to ten (10) year olds.

Ms. Brennan states the adults have also expressed interest, and they may offer courses to them as well; courses such as plant identification and how to build a den.

Member Toppi expresses her concerns about the passage found under Indigenous Land Acknowledge that reads "despite being invaded, displaced, subjugated, massacred, enslaved, and acculturated, these peoples and there culture are still alive and still present today. We honor and respect the first peoples of this land".

Member Toppi wants assurance that they will not be encouraging children to have resentment or hate towards any particular group because of past events.

Ms. Brennan explains that the Tomaquag Museum gave them guidance on how to write this acknowledgement, and they will explain to the children how they took care of the land.

Member Toppi wants to confirm that other disciplines will be taught beside nature. Ms. Brennan explains that she is finishing her certification to become a Level 3 Forest School Practitioner, which will enable her to create a holistic lesson plan. Ms. Brennan further explains that this plan will respect the needs of each child and tie in various facets organically.

Member Toppi wants assurance that a positive environment will be created and acceptable behavior shown towards one another, and asks who will be defining this aspect. Ms. Brennan explains that this will aspect will be created by the leaders of the group, however, community is also an important factor of the forest school, and some lessons will be taught as a community with their guidance. Ms. Brennan assures the members that certain things such as violence and aggression will be addressed as basic ground rules.

Member Toppi also wants assurance that the children will be using the facilities at the Conservation Center. Ms. Brennan assures the members that the children will be using those facilities.

Ms. Baillargeon states that although this is a private company, they would eventually like to get into public schools. Ms. Baillargeon further states that they have been working with the Woonasquatucket River Watershed Council who will have fieldtrips, and they will be able to use their programs. Ms. Baillargeon also states that eventually they would like to host fieldtrips as well.

Member Toppi states that curriculums are always a concern. Ms. Brennan explains that the curriculum is made week by week. Ms. Baillargeon states that their focus is scientific literacy to teach children vocabulary they will encounter in later grades. Member Toppi states that she does not agree with the SEL, and was vague when she did her research.

Vice President Iannotti expresses his concerns about the portable fire. Ms. Brennan explains that it is a small portable fire pit and the fuel used would be sticks. Ms. Brennan further explains that by using a portable fire pit no one would be able to come across a patch in the woods with a fire pit thinking it was a "party spot". Ms. Brennan assures the members that they will clean their area, make sure the fire is extinguished, and an adult is always present at the fire site.

Member Toppi questions if there are any other staff members. Ms. Brennan states that adults are required to stay on site.

Member Toppi asks if integrating into the school would require them to appear again before the Town Council. Town Manager Rossi explains that if they are given access to use the property, they would not need to appear before the council again.

Member Toppi questions if Common Core is being taught. Ms. Baillargeon explains that she teaches what RI standards are being taught. Ms. Baillargeon further explains that she teaches in Massachusetts and that is what is taught. Ms. Baillargeon also explains that they are not required to teach any standards in forest school.

Motion is made by Member Tassoni, seconded by Member Kilduff, that the Smithfield Town Council authorizes a Memorandum of Understanding with the Northern Rhode Island Forest School subject to review by the Town Solicitor. **Motion is approved by a unanimous 5/0 vote.**

B. Consider, discuss, and act upon authorizing the release of two hundred and four thousand dollars and zero cents (\$204,000) in fees-in-lieu-of funding to Gemini Housing Authority for development of a low-tomoderate income housing project.

Attorney Joseph Tudino explains that he is representing Gemini Housing Corporation, which is the nonprofit affiliate of Smithfield Housing. Attorney Tudino further explains that they currently have a verbal understanding to purchase a parcel of property located on Wadsworth Avenue, with a proposed purchase price of \$600,000. Attorney Tudino also explains that the proposal is to build 100% affordable units. Attorney Tudino states that they are seeking the in-lieu funds as part of payment for this purchase.

Member Toppi questions why rentals are being considered rather than ownership. The Director of Gemini Housing Corporation Claire Fortin explains that there is more of a need for affordable rental units. Ms. Fortin further explains that there is only one (1) property in Town that offers affordable rental units.

Member Toppi questions what the expected rent will be. Ms. Fortin explains that for a two (2) bedroom unit the rent will be \$725 and a three (3) bedroom unit will be \$838 (these prices do not include utilities).

Member Toppi questions if there will be an opportunity for ownership. Ms. Fortin explains that this property would be for rental units only.

Member Toppi questions if the Housing Authority looks into vacant buildings rather than being required to clear trees and animal habitats before development. Ms. Fortin explains that they would consider this option, however, they are unable to find anything.

Member Toppi asks the distance of this property from the Village at Summerfield. Ms. Fortin explains that she does not know the distance, however, the property does abut that development.

Town Planner Michael Phillips explains that he does not know the exact distance, however, he thinks it would be approximately several hundred feet. Planner Phillips further explains that there is a Town open space lot that is in between the two (2) properties.

Member Toppi asks if there is a guarantee that Gemini Housing will be able to secure the acquisition grant and tax credit. Ms. Fortin explains that there is not a guarantee.

Attorney Tudino states that while there is no guarantee the funding will be secured, however, the property could be sold privately to recoup the money.

Member Toppi expresses her concerns about the Gemini not receiving the grants. Planner Phillips explains that the property would need to be sold and the Town would need to be repaid by Gemini Housing.

President Lawton questions if repayment by Gemini Housing is a guarantee. Planner Phillips states that is a guarantee.

Member Toppi questions what percentage this development would bring the Town to with regard to LMI. Planner Phillips explains that the percentage will not be raised a great deal, however, every project that consists of 100% affordable housing will make the Town better off because most projects consist of only 25% affordable housing.

Member Kilduff asks how this project will impact the school system. Planner Phillips explains that he spoke with the superintendent to get the numbers from all of the developments.

Member Toppi questions if this development is rent controlled. Planner Phillips believe the rent is based on interest rates and RI Housing sets that rate.

President Lawton wants confirmation that if the council approves this proposal, there still needs to be Planning Board and Zoning Board approval. Planner Phillips explains that this project is a Comprehensive Permit project, this would need to before the Planning Board, who sits as the Board of Review.

Vice President Iannotti states that Planner Phillips told the Affordable Housing Advisory Board that the goal of 10% for LMI will be reached by the year 2060. Vice President Iannotti asks if this project was included. Planner Phillips that this will only help the Town to reach that goal marginally.

Member Toppi asks if any other areas were considered aside from this one. Planner Philips explains that he discussed various sites and buildings that were on the market with Ms. Fortin. Member Toppi asks if all of the members on the board are aware of all of the vacant buildings in Town. Planner Phillips states that he does not get daily updates on vacant buildings.

Member Tassoni questions how long the waiting list is. Ms. Fortin states that the waiting list is approximately five (5) years for Georgiaville Village Green and Greenville Manor (for the elderly and disabled) has a waitlist of five (5) to seven (7) years.

Member Tassoni questions if interest can be added. Solicitor Gallone states that he wants to review the agreement between their entity and the Town. Attorney Tudino states that there would be no problem with repayment. Attorney Tudino further states that something can be agreed to with the Solicitor.

Motion is made by Member Tassoni, seconded by Member Kilduff, that the Town Council allocate the entire balance of the funds in the Fee-in-Lieu of account to General Housing to assist with the acquisition of Assessor's Plat 42, Lot 130, with the caveat that if the property is sold, the Town must be reimbursed. **Motion is approved by a 4/1 vote**. *Member Toppi votes nay*.

C. Consider, discuss, and act upon a pole petition from RI Energy Co. to install new poles on Mowry Road.

Public Works Director Gene Allen explains that the poles are to service a new house, which would be an extension of the existing line.

Motion is made by Member Tassoni, seconded by Member Kilduff, that the Smithfield Town Council approve the pole petition WR30708477 from the RI Energy Co. to install two new poles on Mowry Road as described in the attached petition. **Motion is approved by a unanimous 5/0 vote.**

D. Consider, discuss, and act upon a pole petition from RI Energy Co. to install one new pole on Log Road.

Director Allen explains this will be for a new home that is being constructed.

Motion is made by Member Tassoni, seconded by Member Kilduff, that the Smithfield Town Council approve the pole petition WR30726357 from RI Energy Co. to install one new pole on Log Road as described in the attached petition. **Motion is approved by a unanimous 5/0 vote.**

E. Consider, discuss, and act upon authorizing a contract with JMB Mechanical, utilizing RI Master Price Agreement #136, for the replacement of two (2) HVAC units at the Town Hall in an amount not to exceed fifteen thousand, seven hundred, fifty dollars and zero cents (\$15,750.00).

Town Manager Rossi explains that the town hall has numerous split units for the external office spaces, and some of the units are well past their time and are over twenty-five (25) years old. Town Manager Rossi states that these units will be more energy efficient and will cool during the summer.

Vice President Iannotti questions the \$30,000 that is in the Capital Plan and if it is for all of the units. Town Manager Rossi states this would be a combination of the units and upgrades to the air handlers.

Vice President Iannotti questions where the funds would come from. Town Manager Rossi states that the funds have been budgeted over the years and prior capital.

Member Kilduff questions if the Town has ever done business with JMB in the past. Town Manager Rossi states that the Town has not worked with them in the past, but they are a smaller outfit.





Chapter 5 Licenses Generally

R.I. Gen. Laws § 3-5-16

§ 3-5-16. Maximum number of licenses.

(a)(1) The department of business regulation shall have the right and power to limit the number of licenses of each class. The limit shall not exceed the maximum number, if any, of any class of license that is fixed by the licensing boards within their respective towns or cities.

(2) The number of Class C licenses in any town or city shall not exceed one for each one thousand (1,000) of its inhabitants.

(3) Every city and town may grant in any year renewals of any license of Class A in operation prior to April 28, 1969, except when renewal of that license is refused for cause, but no further new and original licenses of Class A shall be granted until the number of licenses of Class A outstanding in any city or town has been reduced to less than one for each six thousand (6,000) of its inhabitants (one for each four thousand (4,000) of its inhabitants in any city or town with less than twenty thousand (20,000) inhabitants), as determined by the last census taken under the authority of the United States or the state, by cancellation, revocation, or the failure of holders of those licenses to apply for renewals. However, two (2) Class A licenses may be issued by every city or town of the state irrespective of population and, until the qualified electors of any city or town shall vote to the contrary, one Class A license may be issued in every city or town in this state unless otherwise ordered by the city or town council.

Any Class A license issued to or held by a Class E licensee pursuant to the provisions of § 3-7-5 shall be included in the total of, and subject to the limit upon the number of, Class A licenses which may be granted by any city or town under this section.

(b) The transfer of any existing license from the holder of this license to another person shall not be considered as the issuance of a new license under this section.

(c) The several cities and towns, except those cities and towns that had in effect on June 1, 1971, a limit on the number of retailers' Class B or D licenses, shall not issue any new retailers' Class B or D licenses until May 1, 1972. The provisions of this section shall not apply to any application filed on or before May 30, 1971.

(d) Notwithstanding the provisions of subsection (a) of this section, irrespective of the population of the town of Smithfield, it is expressly authorized to issue a total of five (5) Class A liquor licenses.
