As members of the Trail Committee I have a few questions that would be helpful to have answers for by the next Board Meeting to guide my future projects:

- 1. Are there any areas identified in my survey of Wolf Hill you'd like me to move forward on addressing in upcoming weeks?
- 2. I have measured and planned for the bridges for the Northern Loop of Latham Brook. I am under the impression I can begin to gather cedar for this project. The price quote I received was for \$150-\$250 with my assistance. Do I have a go-ahead to transport cedar to Revive the Roots and begin milling trusses with Bradford Allard?
- 3. Will the Land Trust purchase or obtain a drill for the construction of upcoming bridges in Latham Preserve and Wolf Hill?
- 4. Shall steps be taken to develop a step-by-step procedure for dealing with ATV incursions? I am under the impression that there is no formal process currently. I propose the following to be documented photographically and will offer to implement it:

1st violation: Post signage and document tracks

2nd violation: Create some form of barrier (log or stone)

3rd violation: Written notification (if we know the originating location). 4th violation: Smithfield PD notification (This would include all of the above

documentation with photos to demonstrate non-compliance)

5. A second round of Marley's Hiking Challenge is set to roll out to LaPerche Elementary and Pleasant View Elementary students for the week of April 7-16. Shall I flag a "Self Guided Loop" marked by colored ribbon in Latham Brook Preserve?
